

St Barths is open again to ALL travel and tourism!

Some FAQ to assist with some of your Covid enquiries!!

Q When can I travel to St Barths?

A *St Barths reopened to all ALL travel and tourism on June 22nd.*

Q What are the Covid safety requirements for entry to the island and to the property?

A *You will be asked to provide proof of a Covid-negative RT-PCR test performed within 72 hours of your flight. You must show this on entry at the port or airport **and** to your hotel reception. Please email a copy to us before arrival but you must still show proof on entry to the island. YOU WILL NOT BE ALLOWED ENTRY TO THE ISLAND WITHOUT THIS.*

Q What if I didn't get tested, my results didn't arrive in time or are older than 3 days?

A *If you do not have proof of a Covid-negative RT-PCR test performed within 72 hours prior to your flight, you will NOT be allowed entry to the island. UNLESS you are coming from the Schengen area and have been there for over 14 days. For these clients only - if your results are older than 72hrs you will be allowed entry but must take a test within 24hrs of arrival and follow strict quarantine until your results are received. (Usually within 24hrs) NB check the requirements below corresponding to the island you are transiting through, for example Saint Maarten the RESULTS cannot be older than 3 days.*

Q We are transiting through another island, will they have different requirements?

A *Yes - This varies but presently as follows:*

SXM - Juliana airport St Maarten – Airport reopened on July 1st and is due to open to flights from the USA on August 1st – Passengers are required to show proof of a negative Covid-19 taken within 72 hours of their departure flight. Passengers will be subjected to thermal screening and temperature checks on arrival and random Covid testing. You will be required to wear a face mask inside the airport at all times. Passengers must complete this online form at least 12 hours BEFORE travel <https://stmaartenehas.com/application-form/> **and** upload proof of their negative tests. Passengers arriving from France are obliged to also complete this [form](#).

NB_The French-Dutch internal borders on St Maarten/St Martin are currently being controlled and U.S. visitors are not permitted entry to the French side of the island at this time.

By boat from St Martin French side - Same conditions apply as St Barths, i.e. you must have proof of a negative test within 3 days prior to travel **unless** you have been in St Martin for over 14 consecutive days as free movement has already been restored, without testing or quarantine between the French islands.

ANU - Antigua – You will be asked to provide proof of a Covid-negative RT-PCR test performed within 7 days of your flight. You are required to wear a mask at the airport, disembarking the planes and in all public areas. You will be monitored on arrival with random testing and temperature checks. You must also complete a [health declaration form](#). In transit you must distance yourself from other passengers and if you are obliged to transit overnight you will be accommodated in a government bio-secure hotel or accommodation centre.

SJU - San Juan, Puerto Rico – All travellers must wear a mask in the airport and in any building in Puerto Rico. All inbound passengers will be obliged to provide proof of a negative Covid test taken within 72 hours prior to travel. Passengers will undergo a COVID-19 screening on arrival. The screening is located just outside of baggage claim. The screening involves questions about your health and a quick temperature check. If you are identified to have symptoms of COVID-19, you will be required to quarantine.

PTP – Point a Pitre, Guadeloupe – Same conditions apply as St Barths, i.e. you must have proof of a negative test within 3 days prior to travel **unless** you have been in Guadeloupe for over 14 consecutive days as free movement has already been restored, without testing or quarantine between the French islands. You will be required to wear a face mask inside the airport at all times. Passengers arriving from France are obliged to also complete this [form](#)

Q Do children need a test?

A Children aged 11 and below are not subjected to testing.

Q What if we are on the island for a long stay?

A If you are staying on the island for a period that exceeds 7 days, a second RT-PCR test will be required for all clients coming from USA on Day 7 following your arrival and you must show this to us in order to be able to remain in residence.) European clients are not presently required to take a test on day 7 unless of course you display any symptoms.

Q We are staying for 7 nights, does that mean we need a test on our last day?

A No – the test would be due on your 8th day, and as you are leaving that day, it's not required.

Q How long will it take to get test results on St Barths?

A Test results will take less than 24 hours to be released.

Q We live in or have been staying in Guadeloupe/St Martin/Martinique do we still need a test before we come?

A It depends - Testing does not apply to people who have spent the last 14 days in Guadeloupe, Martinique, or Saint-Martin as free movement has already been restored, without testing or quarantine between the French islands. If you have been off island within the 14 day period to another territory other the 3 mentioned then you WILL be required to take a test.

Q How can I get a test on St Barths?

A Tests are now being carried out without appointments - you should present yourself at the laboratory BIO POLE ANTILLES Rue Pithéa La Pointe - Gustavia from Monday-Friday between 2pm-3pm or Saturday 9am-10am. You must have your passport or ID and wear a face mask. You will need to take a number and wait for your turn. There is NO Covid screening outside these hours. The laboratory will provide you with the results within 24 hours.

Q How much does the test cost?

A The test costs €125 per person or free of charge if you have a French social security "carte vitale"

Q What if I've already had Covid and have antibodies, do I still need a test 3 days before I travel?

A YES - As it currently stands, there is not enough evidence to confirm that having had Covid & having Covid antibodies protect you from further infection or from spreading the virus, so the island is still requesting proof of a Covid-negative RT-PCR test performed within 3 days prior your visit to

the island. However, the science is evolving rapidly so if this advice changes, we will certainly advise accordingly.

Q What if I develop Covid symptoms on island?

*A If you develop a fever or a new and persistent cough or a loss of taste or smell you must inform us immediately and we will put you in touch with the relevant health professionals. They will issue guidance and you must **strictly** follow their instructions.*

Q What happens if I test positive on the island?

*A You and your immediate party will be obliged to isolate in your villa and follow **strict instructions** as issued by the health professionals and authorities on the island.*

Q When can we leave isolation and will I have to pay for the accommodation to stay on?

*A (i) The health professionals will advise you when you can safely leave, it is likely to be once you are no longer showing any symptoms **and** subsequently test negative.*

(ii) Yes - you will need to pay for the accommodation and any other costs, so please ensure you accept full responsibility for this before travel and/or have adequate and appropriate travel insurance in place.

Q Is there a hospital on the island if I need it?

A Yes - there is a small hospital and we have excellent doctors on island; however, facilities are limited and in case of extreme emergency you would be evacuated to St Martin or Guadeloupe.

Q Do we need to wear a face mask on the island?

A As of 17th July wearing a mask is now compulsory in all shops, places of worship, shopping centres, banks, taxis, airports and inside hotels for anyone over the age of 11. You may be fined up to €135 for non-compliance.

In restaurants and bars, including on the terrace, the rules are unchanged: wearing a mask when arriving at the establishment or moving around inside. You are not required to wear a mask outside. We do have spare disposable masks at Les Ilets if required. Les Ilets villas are all individual, there are no indoor or enclosed public spaces at our property so you are not required to wear a mask around Les Ilets, at the beach or inside your villa. The office is currently closed to guests.

Q What if I have to cancel last minute due to a Covid related issue?

A Concerning our specific Covid-19 cancellation policy - if travel is impossible due to Covid-19 illness, restrictions, or change of government advice concerning travel, we would roll over deposits for a future stay, valid for 18 months.

Q Is there Covid on the island?

A St Barths had been Covid free since mid-April but currently had 3 cases – all in isolation at home.

Q Are shops, restaurants and water sports and other activities open this summer?

A Yes - Life on the island has returned to normal. Island beaches are open without restriction, restaurants and boutiques are operating as usual, houses of worship are open and holding services, and nautical activities as well as the other services to which you are accustomed are being provided as usual. Some of the larger hotels will remain closed until October. We can provide you with a full "summer" restaurant list if required. *As of August 1st, all restaurants and bars must close by midnight until further notice.*

Q Do we need a test to travel back home?

A Currently no negative PCR test is required from travelers departing from Saint-Barthélemy to France or the Schengen area. This test exemption applies both to travelers passing through Juliana and Pointe-à-Pitre. San Juan does not currently require a negative PCR test if you are in transit. USA does not currently require a negative PCR test for returning travelers however please check for updates or changes with your Government Travel Advisory Service.

Q Will I have to quarantine on return to my country of residence?

*A You will need to verify the specific government travel advice that applies to your country but currently NO quarantine is required on return to the US, France or the UK *Canada currently require 14 days quarantine on return but this advice is subject to review.*
